Sub:- GAD - Observance of 'Sadbhavana Diwas' on August 20th, 2014 – reg.

20th August, the birth anniversary of late Shri. Rajiv Gandhi, is observed as "Sadbhavana Diwas" nation-wide every year. The theme of Sadbhavana is to promote National Integration and Communal Harmony among people of all religions, languages and regions. Goodwill towards everyone and eschewing violence are the motto of the Sadbhavana Diwas. To promote this theme further, the fortnight beginning from 20th August 2014 to 3rd September 2014 will be observed as "Communal Harmony Fortnight" as in the past. All District Collectors, Head of Departments and Public Sector Undertakings will ensure that pledge taking ceremony shall be arranged in all offices under their control on 20th August, 2014 (Wednesday). They shall also arrange befitting programmes to foster Communal Harmony and National Integration during the Communal Harmony Fortnight. The text of the pledge is given below:
