Incremental Learning Approach(ILA) is a component of the POSHANAbhiyaan (SampushtaKeralam). For proper implementation of the scheme training has to be given to various officers at State, District, Block and Sector level on Modules designed for ILA. SRG training for modules up to 18 has been completed. Training on Module 19,20, and 21 has to be imparted to District Resource Group ,Block Resource Group And Sector Level Resource Group.Directions were given to programme officers for conducting these training vide ref(4).

As per Government of India guidelines Rs 4000 (Rupees Four Thousand only ) can be utilized for conducting BRG training for each module and enough funds are sanctioned for this purpose vide ref (1) , (2)&(3).Programme Officers requested fund for conducting BRG Training.

In the above circumstances sanction has accorded to allot **Rs18,24000.00/- (Rupees Eighteen lakhs Twenty Four ThoudandOnly)** to District Women and Child Development officers as given below;
