ORDER

Director of Social Justice vide letter read above has submitted the proposal for the creation of various posts in related components of ICPS, ie State Child Protection Society (SCPS), District Child Protection Society (DCPS), State Adoption Resources Agency (SARA), State Project Support Unit (SPSU), Child Welfare Committee (CWC), Juvenile Justice Board (JJB). As per the ICPS guidelines and as per the proposal of the Director of Social Justice the Central & State share of expenditure of salary of staff in SCPS, DCPS, SARA is in the ratio of 75:25 and in CWC & JJB it is 35:65. The full expenditure of salary of staff in SPSU will be met from the Central share.

2. Government have examined the matter in detail and are pleased to accord sanction for the creation of the following posts in, SCPS, DCPS, SARA, SPSU, CWC and JJB.

- (i) The present PDMC Cell in the Directorate of Social Justice should be abolished and the post of Assistant Director and Senior Superintendent will be converted to the proposed SPSU.
- (ii) The six Ministerial Staff, that became surplus should be reported before the Committee headed by Chief Secretary for further deployment.

4. The Director of Social Justice shall submit necessary proposals for making appointments to the above posts to Government wherever necessary.


