

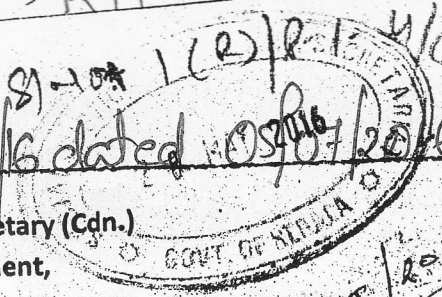

- h. Annual total expense in 2014-15 and its broad break-up

3. RECORDS AND DATA OF EACH PERSON LIVING IN OLD AGE HOME/FACILITY: Kindly provide the following data about each person who is using or has used Old Age Home/Facility in the past five (5) years:

- o. If the person hails from a different state (in India) than where he/she is put up, what effort was made to contact either his/her relatives or the relevant authorities in their state? (Kindly provide record of the same).
- p. If the person was ordered for detention then kindly provide record of the reason for doing so.

- q. Health records with date: All health check-ups done, specialist/doctors consulted, health problems diagnosed, prescriptions made and medication administered; Positive effects or negative side-effects of medications administered.
 - r. Health records for special medical problems like HIV/AIDS, TB, Cancer, Dengue, Leprosy, Psychiatric disease, etc.
 - s. If the person is a Female, then kindly provide records of special health care provided to her.
 - t. Records of government benefits provided like widow pension, old age pension, physically challenged support, ration card, voter ID, Aadhaar card, etc.;
 - u. Details of bank accounts maintained. If the person does not have any bank account, kindly provide record of reason as to why such support was not provided to him/her.
 - v. Records of economic support provided, if any, for instance to meet cost of health treatment or for any other purpose.
 - w. Records of any appeals or complaints made by the person, and action taken to resolve his/her appeal or complaint. If the person needed legal help in order to present his/her appeal/case, record of providing such help. If the person was satisfied after resolution of his/her appeal, kindly provide record of the same. If such help was not provided or action was not taken or the person was not satisfied, kindly provide record of the reason for the same.
 - x. If the person died during his/her stay at the Old Age Home/Facility, kindly provide records (with date) of reason for death, post-mortem conducted, doctor's report, police's report, relatives or friends informed and invited, and burial/cremation carried out. If any of these activities were not undertaken then kindly provide record of reasons for the same.
 - y. Present whereabouts of persons who have left the Old Age Home/Facility; Records of efforts made to contact them to assure that they are fine, healthy and economically stable.

Number of old and economically weak persons at the beginning of the year; out of which how many are living in old age homes/facilities, how many are still on streets, how many live with their families, how many are in jails, and how many in other facilities? Break-up of this data based on state, district, age-group, gender, caste, religion, specific disability categories, etc.
